TransLink Ekka go card Promotion

By entering the **TransLink Ekka** *go* **card** promotion ("the Promotion"), you agree to the following terms and conditions:

1. THE PROMOTER

2. STANDARD TERMS

- 4.2.3 follow the TransLink Instagram page.
- 4.1.4 The time of entry will, in each case, be the time that the entry is recorded on the servers of the Promoter, not at the time of transmission by the entrant.

5. HOW TO WIN

- 5.3. The winner will be notified via Instagram and their name will be published on TransLink's social media channels and via electronic direct mail to TransLink's database following the Promotion.
- 5.4. The Promoter's decision in relation to any aspects of the Promotion is final and the Promoter will not enter into any correspondence regarding the result.
- 5.5. The Promoter reserves the right to verify, or to require the entrant to verify that the entry is the entrant's original work. If an entry cannot be verified to the Promoter's satisfaction, the entry will be deemed invalid.
- 5.6.  or programming associated with, or utilised in this Promotion, or for any technical error, or
 combination thereof that may occur in the course of the administration of this Promotion,
 including any omission, interruption, deletion, defect, delay in operation or transmission,
 communications line or telephone, mobile or satellite failure, theft, or destruction or
 unauthorised access to, or alteration of, entries;
 - any technical difficulties or equipment malfunction (whether or not under the Promoter's control);
 - any theft, unauthorised access or third party interference;
 - any entry or prize claim that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;
