Bringing onto a train designed for passengers a thing which, because of its size or shape, cannot be put (a) under the seat; or (b) in an overhead rack; or (c) in a designed storage area <sup>2</sup>	\$266
Placing an item where it may cause obstruction or injury <sup>2</sup>	\$266
Selling, seeking business or conducting a survey on a railway <sup>2</sup>	\$266
Selling or seeking business or conducting a survey on a regulated area <sup>3</sup>	\$266
Playing a musical instrument on a railway <sup>2</sup>	\$266
Playing a musical instrument or operating sound equipment on a regulated area <sup>3</sup>	\$133

Driving a vehicle (other than a wheelchair) on a bridge, or platform, or in a subway <sup>2</sup>	\$266
Driving on a busway or busway transport infrastructure or light platform designed for pedestrian use <sup>3</sup>	\$266
Parking on a busway or busway transport infrastructure except in an authorised place <sup>3</sup>	\$266
Failure to obey a sign about driving or parking a vehicle on a busway or busway transport infrastructure <sup>3</sup>	\$266
Failure to enter or leave at a designated entry or exit <sup>3</sup>	\$266
Obtaining hire or use of a vehicle by fraud or misrepresentation <sup>1</sup>	\$533
Driving on a busway or busway transport infrastructure at more than the permitted speed <sup>3</sup>	\$266
